How to leave a legacy gift.

One way for you to leave a legacy gift to the Glenrose Hospital Foundation is to bequest provisions to your Will.

What is a bequest?

A bequest is the most common type of planned (legacy) gift. It is a gift, left in your Will, and designated as you see fit. Bequests can take several forms; they can be a specific amount, a particular asset (e.g. a property or investment), or a percentage portion of your estate. Bequests made to charitable organizations may help minimize taxes to your estate.

How do I make a bequest in my Will?

Begin by speaking with your Lawyer about your intentions. We have provided some sample bequest wording below that can be used in your Will.

For a specific amount:

"I give \$_____ to support the work of the Glenrose Rehabilitation Hospital Foundation, charitable registration number 89101 6347 RROOO1".

For estate (either portion or whole):

"I bequeath the residue of my Estate (or ___ %) to the Glenrose Rehabilitation Hospital Foundation, charitable registration number 89101 6347 RROOO1".

What if I want to designate my gift to a specific program or area?

What are the benefits of including a bequest in my Will?

There are many reasons to consider leaving a legacy gift to the Glenrose Hospital Foundation in your Will:
